Further to the e-mails below I've had a chance to look at drawing 402884-10-01. Any development of the scale proposed should provide safe access for both vehicles and pedestrians. There is no footway along High Green in the vicinity of the site and the presence of third party boundaries close to the road edge appears to prevent the construction of a new footway to link the site with the existing provision adjacent No 1 Astley Cooper Place. In addition, whilst the layout plan suggests a potential footway link could be provided through to Astley Cooper Close (Adj Nos 8 & 9), given the red line site boundary and the existing highway boundary on Astley Cooper Close there appears no realistic expectation that this could be provided.

If constructed as proposed the development would inevitably give rise to additional pedestrian movements, all reliant on walking significant distances along an unlit carriageway in order to access local services, to the detriment of highway safety. With regards to vehicular access we would expect sightlines of 2.4m x 59m. In light of the above we have principle concerns as to whether this site can offer safe pedestrian and vehicular access. If this proposal were presented to us as a formal application then on the basis of the evidence submitted we would have no option but to recommend it be refused in the interest of highway safety. We will refrain from commenting on layout until such time when/if the access concerns can be satisfactorly addressed.

I am sorry your proposal is unacceptable, but I am sure you will appreciate the need to safeguard highway safety.
